CAPTAIN - TRAINING

Training is the cornerstone of every great organization. The prospective candidate will have current industry knowledge, training and development experience. The position will report to the Deputy Chief of Training. The Captain will oversee training classes for all employee classifications. This position is Exempt for purposes of Federal Wage-Hour Laws, which means that you will not be eligible for overtime pay for hours actually worked in excess of 40 hours in a given workweek. Schedule will be a traditional Monday through Friday workweek, occasionally flexing to nights and weekends depending on department needs.
